SELMA launch new website to tackle online hate

The Social and Emotional Learning for Mutual Awareness (SELMA) project, has launched a new website promoting mutual awareness, tolerance and respect. The project, which is supported by the South West Grid for Learning (SWGfL) and co-funded by the European Commission,

looks to tackle to the growing problem of online hate speech.

For many people the internet can be a hostile place. Social media is a common place for hateful messages to be found. The website is targeted at 11-16 year olds, and aims to help young people better understand online hate and provide them with the tools and strategies to act against hate speech.

Mental Health in Schools



Children and young people's mental health -Prime Minister's announcements

The Prime Minister has made a series of announcements

regarding children and young people's mental health.

Recruitment has now begun for new mental health support teams who will work with schools to ensure young people with mental health issues get the help they need - trainees will begin studying in January and join schools across England next year.

Starting in 2019, the government will publish a 'State of the Nation' report every year on World Mental Health Day, highlighting the trends and issues in young people's mental well-being - the first time children's mental health will be reported in this way, alongside their physical health and academic attainment.

The government will provide tools to help schools measure their students' health, including their mental wellbeing – building on the commitment to make education in mental health and resilience a compulsory part of the curriculum.

New toolkit developed to tackle work-related stress in schools

The HSE's Go Home Healthy campaign has launched a new downloadable 'Talking Toolkit' aimed at preventing work-related stress.

The 'Talking Toolkit' is a simple, practical guide to help senior leaders in schools to have conversations about issues which may be causing or could in the future cause work-related stress if not managed properly. The toolkit has six templates for six different conversations as well as a range of ideas and resources from charities,

Trade Unions, the DfE and Ofsted which schools can use to prevent stress.

Work-related stress is an increasing issue in all sectors with Education having the third highest rate of stress, depression or anxiety per 100,000 workers. Over half a million working days were lost in secondary schools in the last 12 months.

The 'Talking Toolkit' is designed to help schools to take the first steps in preventing work-related stress

Cumbria LSCB launch new Risk Assessment tool for Child Exploitation

The new multi-agency risk assessment tool for Child Exploitation is now available for use via the 'Appendices and Protocols' section of the LSCB

documents library. The new tool has been developed to include all aspects of child exploitation not just CSE to align itself with the 'Signs of Safety' methodology

and replaces the previously available tool.



New website on policing and preventing child sexual abuse

The National Police Chief's Council (NPCC), Victim Support and the Children's Society has created a new website of resources around policing and preventing child sexual exploitation (CSE) and abuse. The CSE Policing and Prevention website includes toolkits and guidance around such issues as child criminal exploitation in relation to county lines; harmful sexual behaviour; supporting parents and carers and working with children and young people who have physical disability.

Asbestos Management in schools



The HSE will shortly be commencing a programme of single issue inspections in schools to assess the effectiveness of the management arrangements to control the risks

associated asbestos-containing materials in schools.

Any school building built or refurbished before the year 2000 has the potential to contain some form of asbestos containing

material unless it has since been removed. If left undisturbed, the material poses no risk.

The problem, however, is that in many cases, people such as site staff and contractors are not made aware that the asbestos is there.

Schools **MUST** ensure that they have up to date records of the asbestos on site. Survevs which have been carried out must be checked to ensure that all areas have been investigated and if any areas are missing they must be re-visited to complete the
